Market review

Some competing forces affected sentiment towards Asian credit in the second half of 2021. Tighter regulations introduced by Chinese officials on property firms, a crackdown in the private tuition industry, and increasing scrutiny in the digital and online sectors saw investors rein in their risk appetite.

A sharp rise in cases of the COVID-19 Delta variant also forced some economies to re-introduce social distancing measures; Indonesia became one of the worst affected countries in the region.

These issues also weighed down Asian equity markets, with China ending the 6-month period as the worst-performing market in the region. South Korea also underperformed, as sentiment on the technology sector weakened. Meanwhile, despite the rolling restrictions, Indonesia outperformed as good progress on vaccinations helped to lift market sentiment. The Indian stock market also performed well over the period, based on improved economic activity, decent company earnings results and an optimistic growth outlook.

On the positive side, the Huarong saga that took center stage in the first half of the year was resolved after the company received a state-led capital injection. This news helped support spreads in the investment grade space. The company announced that state-owned investors including CITIC Group, China Insurance Investment and China Life Asset Management will replenish its capital levels. The size of these strategic investments has not yet been disclosed, but press reports indicated the inflows amounted to around RMB50 billion (or more than US\$7 billion). The capital injection alleviated concerns about a potential debt restructure. It now appears the company will have sufficient capital to remain solvent and that state support will be forthcoming, if required. With the new backing confirmed, the company will likely focus on divesting non-core subsidiaries to further boost capital levels. This alleviated concerns regarding a possible debt restructure.

In the high yield sector, valuations declined sharply in the second half of the year, as investors were unsettled by headlines on possible debt extensions, non-payments, and credit rating downgrades in the Chinese property sector, which accounts for a meaningful component of the high yield index. Initially concern was focused on Evergrande, though later spilled over and affected other property developers. Shimao was downgraded to high yield from being a cross-rated issuer and few low-rated high yield names defaulted. On the policy front, there was a relaxation in credit measures to ease liquidity, although tight policies on housing remained in place.

Separately, Federal Reserve policymakers suggested interest rates in the US might be increased in 2022. Initially, the central bank reiterated that high inflation would be “transitory”, but later dropped this message and indicated inflationary pressures could be more persistent. By year end, inflation in the US had quickened to 7.0% – the fastest annual pace for around 40 years – increasing the likelihood that policy settings will be tightened. This resulted in an increase in government bond yields and weighed on the performance of fixed income markets worldwide, including Asian credit. Ultimately, while credit fundamentals of corporate issuers in Asia remain supportive, Treasury yields will impair total returns if they continue to trend higher.

Outlook

In terms of portfolio positioning, the Fund remained positioned for an anticipated increase in US Treasury yield. Overall exposure to credit was also lowered. Within the Fund's credit allocation, we added high quality, investment grade names and increased diversification away from China. We also added Medco Energy, a high yield Indonesian oil and gas company, to help enhance potential returns. Rising commodity prices are favorable for the company. Elsewhere, we took some profits in a few bonds that had performed well and reduced overall exposure to Indonesia as rising US Treasury yields could result in a broader sell-off in emerging markets.

Investment grade credit spreads ended the year below the five-year average, suggesting there is limited scope for further tightening. Moreover, the narrow spreads provide little buffer for rising US Treasury yields – all of this suggests returns could remain subdued in 2022.

Meanwhile, the outlook for Asian equities remains uncertain. Persistently high inflation, monetary tightening from the US Federal Reserve and a slowdown in global growth all have the potential to weigh on financial markets. Additionally, Covid variants, rolling lockdowns and border closures mean that a recovery in international tourism and consumer spending will remain challenging, though the situation is expected to normalise gradually after the pandemic-related events of the last two years.
