

Fund Charges and Costs Explained

September 2023

Charges and costs can have a real impact on the returns that you get from a fund so it's important to know what you will pay when you invest in a fund. This document is intended to help you understand the charges and costs you will pay for investing in a fund within the First Sentier Investors ICVC Prospectus and to help you understand how the charges and costs you pay impact the returns on your investment.

What charges and costs will you pay for investing in our funds?

Charges and costs	Paid by fund investors
<p>Entry Charge: This is an upfront charge you pay when buying shares in the fund and is deducted from your initial investment sum. Currently, none of our funds apply an entry charge (also known as an initial charge).</p>	<p>No</p>
<p>Ongoing Charges: This is an annual charge which consists of the Annual Management Charge and additional expenses.</p> <p>The Annual Management Charge is a charge from the investment manager for managing your investments. It varies between the funds and share classes that you can invest in.</p> <p>Additional expenses are fees paid to third parties that provide services to the fund, including audit, custody and registrar services. Additional expenses are capped at 0.20% of the net asset value of the fund which protects investors, particularly in smaller funds, from paying excessive charges.</p> <p>For further details of the charges applicable to our funds, please refer to the First Sentier Investors ICVC Prospectus and the Key Investor Information Documents, which can be found under the "Performance and documents" section of our website at Firstsentierinvestor.com.</p>	<p>Yes</p>
<p>Portfolio Transaction Costs: These are costs incurred by the fund itself when buying and selling investments on behalf of investors. Portfolio transaction costs are made up of explicit and implicit transaction costs.</p> <p>Explicit transaction costs are incurred by the fund when buying and selling underlying investments, including broker commissions, stamp duty and other financial transaction charges.</p> <p>Implicit transaction costs are incurred as a result of the bid-offer spread, which is the difference between the buying and selling prices of the fund's underlying investments and their actual market value (known as the mid-price).</p> <p>Table 1 shows a breakdown of portfolio transaction costs.</p>	<p>Yes</p>

How do the charges and costs you pay impact on the returns of your investment?

The table below shows the impact that charges have on your investment based on a £10,000 lump sum invested for a period of one year. The calculation assumes that the fund's underlying investments do not change in value over the course of the year.

How do we price our funds?

Our funds operate a single pricing methodology and reserve the right to charge a dilution adjustment to protect the fund and its existing investors from the costs of buying and selling underlying investments that result from investors joining or leaving the fund. When we impose a dilution adjustment the single price of the fund is adjusted upwards or downwards (known as swing pricing) and the amount is calculated by reference to the estimated costs of dealing in the underlying investments, including any spread between the selling and buying prices of the investments, broker commissions and stamp duty. The dilution adjustment is paid into the fund and helps to protect existing investors.

Are there any additional charges you might pay when investing in our funds?

Investing through an intermediary such as a fund platform or financial adviser may incur additional charges. Please speak to your financial adviser for more details on this.

**A negative transaction cost indicates that transacting has resulted in a net revenue rather than a net cost to the fund. This can happen if the market moves in favour of the fund in the time between placing the order and executing the order, or if the counterparty to an investment contract makes a payment to the fund.

***The fund has a transaction history of less than 3 years, therefore an average transaction cost cannot be calculated.

****The ongoing charges figures quoted above are based on the expenses incurred for GBP Class B (Acc) classes for the fund financial year ended 31 July 2023. The ongoing charges figures may vary from year to year.
