RESOLUTIONS PASSED

Proposals for a scheme of arrangement for the Merger of the Stewart Investors Global Emerging Markets Leaders Sustainability Fund (the “Merging Fund”) into the Stewart Investors Global Emerging Markets Leaders Fund (the “Receiving Fund”), both sub-funds of First Sentier Investors ICVC

Dear Shareholder,

1. Background

We wrote to you on 26 May 2023 outlining our proposals to merge your fund (the “**Merging Fund**”) into the Stewart Investors Global Emerging Markets Leaders Fund (the “**Receiving Fund**”).

Shareholders of the Merging Fund have voted on the merger and we are now writing to inform you of the results of the vote and to remind you of the actions you may wish to take.

2. Results of the voting and effect of the merger

Shareholders have voted to implement the merger. As a result, your shares in the Merging Fund will be exchanged for shares in the Receiving Fund with the same value on the date of the exchange. This exchange is due to happen on Friday, 14 July 2023.

3. Do I need to take any action?

If you are happy for your shares to be exchanged for shares in the Receiving Fund you do not need to take any action.

If you do not want your shares to be exchanged for shares in the Receiving Fund, you have the following options:

- switch your investment free of charge into another sub-fund; or
- instruct us to redeem your shares and receive the proceeds in cash.

The final date for any redemption or switch is 7th July 2023. Instructions must be received by us by 12 noon (UK time).

The above outlined options are also open to you at any time after you receive your exchanged shares in the Receiving Fund.

There may be tax implications depending on your individual circumstances. We are unable to provide tax advice and we therefore suggest that you seek professional advice if you have any doubt relating to your tax position.

4. Regular investors

If you currently have an active direct debit mandate with a monthly sum being invested in the Merging Fund, the collection of this direct debit will cease and the mandate will now be terminated. The last collection taken for investment in the Merging Fund will be 15 June 2023. If you wish to start a new direct debit mandate for your monthly investment into the Receiving Fund (or an alternative fund managed by us), please complete and return a new regular investment mandate form which is available from us via the contact details under the heading "Questions" below.

5. Questions
